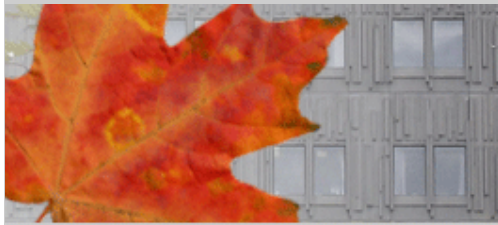

Faculty Message

Times they are a-changing...

As we head into the Fall season many exciting and forward-thinking changes are happening within our Faculty. The official launch of our fourth medical academy (the Mississauga Academy of Medicine) occurred on November 1 at UTM with the opening of the Terrence Donnelly Health Sciences Complex. This event, hosted by President David Naylor and Vice President and Principal (UTM) Deep Saini, was attended by a prestigious group of dignitaries to recognize the exceptional gifts from two outstanding donors; Carlo Fidani and Terrence Donnelly. The podium included speeches from Minister of Health and Long Term Care, Deb Matthews, and Minister of Government Services, Harinder Takhar, Mayor Hazel McCallion, Chancellor David Peterson and the Chair of Governing Council, Richard Nunn, as well as Aleida ter Kuile, a Resident trainee in Family Medicine and Dean Catharine Whiteside. The enthusiasm and momentum that has been generated by this new academy at UTM and with our partner affiliate hospitals at Credit Valley Hospital and Trillium Health Centre is a wonderful testament to the contributions from the public, our faculty, staff and students.

This event and the zeal of the students bode well for the Faculty as the entire undergraduate MD administration busily prepares for the accreditation visit by the LCME-CACMS team in May 2012. Many people across our entire Faculty have been deeply engaged in preparing the self study documents and compiling the database of information pertaining to each of the 128 standards set out by the LCME and CACMS. The database, a comprehensive students' report, and other sources have been reviewed by various institutional self-study committees, the membership of which has been drawn from across the entire Faculty of Medicine. There continues to be tremendous input from medical students, staff, and faculty to the self-study and I wish to thank all of the participants for their volunteerism and dedication to this important task, and most importantly Dr. Martin Schreiber and Ms. Jennifer Anderson, who are coordinating this immense project.

Another major effort is also underway with the planning for significant expansion of Graduate education. Acting Vice Dean, Graduate Affairs, Avrum Gotlieb is undertaking a forecasting process in order to maximize the Faculty's opportunities for growth in new and existing PhD and Professional Master's programs. The Faculty is also positioning itself to take advantage of the Provost's PhD Enhancement Fund (PPEF) Matching Program for which guidelines were issued on November 1, 2011.

As is noted later in this Med E Mail issue, the Department of Health Policy, Management and Evaluation (HPME) was approved by the Governing Council of the University of Toronto on October 27th to become an Extra Departmental Unit (EDU-A)-specifically, an Institute. The search for a Department Chair will now transition to a search for a Director of the Institute. This is a transformative moment in the life of HPME and one which warrants major congratulations to all involved. I especially wish to recognize the exceptional leadership of Professor Louise Lemieux-Charles, Chair of HPME.

As many of you have noticed, the Faculty is in the midst of a changeover in the senior leadership of several units. The composition of advisory committees and the call for nominees, as well as the advertisements for applications, form a

substantial portion of this newsletter, and we engage multiple staff, faculty and learners in the processes. Several Departments have been undergoing self studies and external reviews. The efforts of all in contributing to this work in short time frames, and your generous participation in committee meetings have been deeply appreciated by the Dean's Office. As a result, the Faculty's ability to meet the standards for the cyclical review of units established by the U of T Quality Assurance Framework is greatly enhanced. American Medical Writer's Association Medical Book Award 2011

Dr. Robert Buckman, who passed away mid-October (see [MedEmail Volume 20, Number 4](#)), was the recipient of the American Medical Writer's Association (AMWA) Medical Book Award for 2011 for the "Books for Health Care Professionals - Physicians" category. The AMWA is the leading professional organization for written medical information. The book awards were established over 30 years ago to acknowledge exceptional fictional and non-fictional medical writing.

Pomeranian Medical University (Poland) Honorary Degree

On October 3, 2011, **Dr. Steven Narod** (Department of Medicine), a senior scientist at Women's College Research Institute and a Tier 1 Canada Research Chair in Breast Cancer, was awarded an honorary doctorate by the Pomeranian Medical University in Poland. The honour recognizes his long-standing and influential contribution to hereditary breast cancer research, in particular through his collaboration with the university's International Hereditary Cancer Center. This collaboration has published nearly 100 peer-reviewed articles on various aspects of hereditary breast and ovarian cancer.

Ivey Global Health Conference Student Video Contest

Two undergraduate medical students, **Victoria Leung** and **Erica Merman**, are the winners of the 2011 Ivey Global Health Conference Student Video Contest. The purpose of the contest was to stimulate students to be creative and develop an innovation to improve health care systems. Their video focused on the need for individuals to be aware of proper hand hygiene and the need to improve compliance with hand hygiene best practices. Victoria and Erica have been invited to attend the Ivey Global Health Conference in November 2011, where the video will be presented.

American Congress of Rehabilitation Medicine Fellow

The American Congress of Rehabilitation Medicine (ACRM) named **Dr. Angela Colantonio** (Occupational Science and Occupational Therapy), a Fellow of the ACRM in recognition of her significant contributions to the field of medical rehabilitation and to the ACRM. Fellows of ACRM have made sustained contributions of national significance to the field of medical rehabilitation through clinical practice, research, education, or administration and have demonstrated exemplary service to the ACRM. The American Congress of Rehabilitation Medicine is dedicated to serving the needs of people with disabling conditions by providing research that promotes health, independence, productivity and quality of life. The ACRM is a leader in promoting innovative rehabilitation research, disseminating timely clinical information and

assisting with transfer of technology.

Society for Cardiovascular Pathology Distinguished Achievement Award

Professor Avrum Gotlieb is the recipient of the Distinguished Achievement Award, 2012 from the Society for Cardiovascular Pathology, Boston Massachusetts. This International Society was established in 1985 and is devoted to the advancement of the study of cardiovascular disorders, especially with respect to pathogenesis, diagnosis and treatment.

Hypertension Canada Certificate of Excellence

Dr. Mary L'Abbe, Chair and Professor of the Department of Nutritional Sciences, has received the Hypertension Canada Certificate of Excellence in October 2011. The Hypertension Canada Certificate of Excellence is presented to individuals or organizations in recognition of their outstanding efforts and contributions in Canada through increased public awareness, prevention or control of hypertension.

Faculty of Medicine Continuing Education Awards 2010-2011

This is a reminder that nominations are now being requested for the Faculty's Continuing Education Awards for 2010-2011. These six awards provide an opportunity for the University of Toronto's Faculty of Medicine faculty to be recognized for their outstanding achievement in program development, research, on-line education, teaching excellence, and long-term contributions to continuing education. The awards are named for exceptional University Toronto Faculty recognized internationally for their scholarly contributions to the field of continuing education and professional development.

The six named awards are:

1. The Colin Woolf Award for Excellence in Teaching
2. The Colin Woolf Award for Excellence in Course Coordination
3. The Colin Woolf Award for Long-Term Contributions to Continuing Education
4. The Fred Fallis Award for Excellence in Online Education
5. The David Fear Fellowship
6. The Dave Davis Award for Excellence in Research

These awards are presented to worthy faculty following a rigorous peer review process.

Please submit, **by Monday, November 14, 2011**, the names of faculty in your Department and the Continuing Education programs they have developed which you feel are worthy of a CEPD award. In addition, we have extended the deadline for receipt of materials supporting nomination(s) to **Wednesday, November 30, 2011** (was formerly October 31).

Annual Graduate Faculty Teaching Awards

The Faculty of Medicine will award up to 3 graduate faculty teaching awards annually. The purpose is to honour and celebrate outstanding contributions to graduate education by full time faculty in the Faculty of Medicine who teach in doctoral stream or professional graduate programs. The award will consist of a framed certificate, a cash prize and formal recognition at the Faculty of Medicine Educational Achievement Event on April 30, 2012.

Categories (one award in each category):

Sustained contribution (more than 5 years) to excellence in graduate teaching

This award recognizes sustained contribution(s) to any aspect of graduate teaching including a course, curriculum development, graduate program administration, graduate student supervision or academic role modeling. This individual should demonstrate regular support of their Graduate Departmental activities including participation in seminars, annual scientific days and significant contribution to service on student committees including thesis examinations.

Graduate student mentorship

This award recognizes sustained (more than 5 years) contribution to graduate student mentorship exemplified by but not limited to: major contribution to graduate student learning; enthusiastic and empathic critical appraisal of students' work; timely assessment of students' research programs including program advisory committee meetings and prompt turnaround of written work; and, careful attention to a critical path laid out for students' research.

Early career excellence

This award recognizes outstanding contribution to the training and experience of graduate students, as evidenced by excellence in teaching, supervision or mentorship and dedication to students. This award is restricted to Faculty in the early stages of their career within 5 years of their initial SGS appointment.

Eligibility

The nominee must hold a full time primary appointment in the Faculty of Medicine and be either an associate or full member of the School of Graduate Studies. Contributions to teaching in either the doctoral (thesis MSc or PhD) or professional graduate programs will be considered.

Nomination

Candidates for these awards must be nominated by a Graduate Department through a student (or recent graduate)-initiated process. **Please Note: Each Graduate Department may only nominate ONE faculty member per award category.**

Nomination Deadline: December 9, 2011 (Note: Each Graduate Department will have an earlier internal deadline)

Nominations for these awards are due by **Monday, November 14, 2011** via email to the Faculty Council c/o Todd Coomber (todd.coomber@utoronto.ca). Nominations must include a description of why the nominee fits the selection criteria and, with the exception of the Northrop Frye Departmental award, all nominations must be accompanied by an up to date CV. For the Northrop Frye Departmental award, the nomination must also include supporting material. The Faculty will then assist in the coordination of the complete nomination package.
